CMS Targeted COVID-19 Training for Frontline Nursing Home Staff

Group Facilitator's Guide

Practice and prepare for COVID-19 surges with the Centers for Medicare & Medicaid Services (CMS) Targeted COVID-19 Training for Frontline Nursing Home Staff. This free, fully updated training will walk you through real-world situations so you can deliver the best quality of care to your residents.

The Frontline Nursing Home Staff training includes five modules and can be completed in any order:

- Hand Hygiene and Personal Protective Equipment (PPE)
- Screening and Surveillance
- Cleaning the Nursing Home
- Cohorting
- Caring for Residents with Dementia in a Pandemic

This group facilitator's guide provides everything that you will need to train your staff as a team.

The training is hosted on the [**CMS Quality, Safety & Education Portal \(QSEP\)**](#) and is available on-demand, 24/7.

The training includes a mandatory **pre-test, post-test** and **evaluation**. For nursing home staff members to receive certificates of completion, they must individually score a minimum of 80 percent on the post-test. Continuing education units (CEUs) are not available.

Training Checklist | At Least 2 Weeks Before Training

Communicate to Staff

- Staff members will need to use individual email addresses to register for a CMS Quality, Safety & Education Portal (QSEP) account.
- Each staff member will need to bring their smartphone to each session to complete tests using their own QSEP account to get credit for the course.
- Ideally, staff should sign up for a QSEP account the week before the pre-test and training to save time on training day. The [User Guide](#) includes step-by-step instructions to register for a QSEP account.
- Post [flyers](#) in breakrooms and restrooms to let staff know about upcoming training sessions.

Set the Agenda

- Decide whether to complete the pre-test and post-test as a group.
 - Test questions are randomized.
- Customize the sample agenda to align with your existing all-hands meetings and/or add to new hire orientation sessions.
- Determine how and when to cover each module across multiple sessions or to bundle as time allows. You have the flexibility to complete the modules in any order.

How to Access the Training

- 1 Login to your QSEP account at <https://qsep.cms.gov> (follow steps 1-7 in the [User Guide](#)).
- 2 Select **CMS Targeted COVID-19 Training for Frontline Nursing Home Staff**
- 3 Open the pre-test or navigate to the training.
- 4 When the training launches, click **Menu**. Select the module that you will cover for the day and then click **Start Module**. Click the **Next** arrow to advance or **Prev** arrow to go back.
- 5 At the end of each training module, ask the staff to login to their QSEP accounts, select the appropriate module, and then select **Attempt to Skip**.
 - For each staff member to get credit for completing a module via the group training, they will need to “test out” of the module by answering four of five questions correctly. It is only possible to attempt to skip a module once. Test-out questions for each module are included in the Group Facilitator’s Guide and can be printed or displayed on the projector. If a staff member answers two or more questions incorrectly, he or she will be prompted to repeat the module to receive credit.

Preparing to Train (10 minutes) – Part of an All-Hands Meeting

10 minutes | Pre-Test

TRAINER NOTES:

Display the [welcome sign](#) with the link and QR code for staff to access the training. If possible, ask staff to create accounts in the QSEP system prior to the training date to maximize training time. The 20 pre-test questions are randomized.

TRAINER SCRIPT:

“Today we are testing our knowledge of the latest COVID-19 guidance and preparing for COVID-19 surges with the CMS Targeted COVID-19 Training for Nursing Home Frontline Staff. Please login to your QSEP training account using this QR code or link. We have user guides and a QR code to scan to help you access the QSEP training system. You will need access to an individual email address to register for a QSEP account if you haven’t already done so.

There are 20 questions to answer. Read each question carefully. Some questions may have more than one answer. Click on “Submit Answer” to go to the next question. Do not click the Back browser button. If you do, you will exit the test. The pre-test is not scored and is a way to see how the training improves our knowledge.”

Module 1 (50 minutes)

2 minutes Welcome | Brief Announcements

45 minutes **Module 1: Hand Hygiene and Personal Protective Equipment**

TRAINER NOTES:

There are several places where the narration pauses to allow for interaction with the audience (i.e., knowledge checks, who wore it best). You can read the content on the screen aloud and ask the group to vote on the answer by a show of hands. The answers will be shown upon clicking with an explanation that you can read aloud before moving on. There are also opportunities to briefly discuss any procedures specific to your facility (e.g., donning/doffing) that you may wish to emphasize.

3 minutes **Knowledge Test**

TRAINER NOTES:

Ask staff at the conclusion of the module to go into Module 1 and “attempt to skip.” The test-out questions and their response options are included in this guide. You may wish to print these out or display on screen.

TRAINER SCRIPT:

“As we end this section, please be sure that you are logged in to your QSEP account and navigate to the training. We have user guides and a QR code to scan to help you access the QSEP training system. Today we completed Module 1: Hand Hygiene and Personal Protective Equipment (PPE). Please go into the training in QSEP, navigate to the menu within the training, and click on that module. Then, click “attempt to skip”. Completing these 5 test-out questions will help reinforce what we learned today and ensure that you get credit for completing today’s module. You must get 4 out of 5 questions correct in order to successfully test out. If you do not answer 4 out of 5 correctly, you will be prompted to repeat the training module.”

Knowledge Test for Module 1: Hand Hygiene and PPE

The answers will be shown upon clicking with an explanation that you can read aloud before moving on.

Ask staff at the conclusion of the module to go into Module 2 and “attempt to skip.” The test-out questions and their response options are included in this guide. You may wish to print these out or display on screen.

There are links within this module that you do not need to review with the team. You can opt to download any signs or tools that may be helpful to share with your staff at a later time. There is a link to graphic novel about Environmental Services staff that walks through different scenarios. The content presented is covered within the training module. However, you may wish to pause and read 1-2 scenarios aloud.

3 minutes **Knowledge Test**

TRAINER NOTES:

Ask staff at the conclusion of the module to go into Module 3 and “attempt to skip.” The test-out questions and their response options are included in this guide. You may wish to print these out or display on screen.

TRAINER SCRIPT:

“As we end this section, please be sure that you are logged in to your QSEP account and navigate to the training. We have user guides and a QR code to scan to help you access the QSEP training system. Today we completed Module 3: Cleaning the Nursing Home. Please go into the training in QSEP and click on that module. Then, click “attempt to skip”. TRAINER NOTES:

There are 8 knowledge checks that help the team review a case and determine the best course of action for a patient. You can read the content on the screen aloud and ask the group to vote on the answer by a show of hands. The answers will be shown upon clicking with an explanation that you can read aloud before moving on.

3 minutes **Knowledge Test**

TRAINER NOTES:

Ask staff at the conclusion of the module to go into Module 4 and “attempt to skip.” The test-out questions and their response options are included in this guide. You may wish to print these out or display on screen.

TRAINER SCRIPT:

“As we end this section, please be sure that you are logged in to your QSEP account and navigate to the training. Knowledge Test for Module 4: Cohorting

There are 3 knowledge checks that help the team review a case and determine the best course of action for a patient. You can read the content on the screen aloud and ask the group to vote on whether something is true or false by a show of hands. The answers will be shown upon clicking with an explanation that you can read aloud before moving on.

3 minutes **Knowledge Test**

TRAINER NOTES:

Ask staff at the conclusion of the module to go into Module 5 and “attempt to skip.” The test-out questions and their response options are included in this guide. You may wish to print these out or display on screen.

TRAINER SCRIPT:

“As we end this section, please be sure that you are logged in to your QSEP account and navigate to the training. We have user guides and a QR code to scan to help you access the QSEP training system. Today we completed Module 5: Caring for Residents with Dementia in a Pandemic. Please go into the training in QSEP and click on that module. Then, click “attempt to skip”. Completing these 5 test-out questions will help reinforce what we learned today and ensure that you get credit for completing today’s module. Post-Test and Training Evaluation (15 minutes)

15 minutes Post-Test and Training Evaluation

TRAINER NOTES:

Staff must answer at least 16 of 20 post-test questions correctly to receive a score of 80 percent or better. Then, the staff will complete an 11-question training evaluation. Both the post-test and the training evaluation must be completed to receive a certificate of completion. After successfully completing the post-test and training evaluation, staff will be able to view and save, email or text their certificate of completion.

TRAINER SCRIPT:

“With this final module, we have completed the training and are prepared to protect our residents and each other from COVID-19. In order for us to get credit for completing the training, we need to complete a post-test to show that we are up-to-date on the latest COVID-19 guidance. Please login to your QSEP training account. Then, scan the QR code and select the post-test from the training menu. We have handouts and instructions on the screen. Read each question carefully. Some questions may have more than one answer. Click on Submit Answer to go to the next question. Do not click the Back browser button. If you do, you will exit the test. The post-test is scored. You must answer at least 16 questions correctly to pass. You can retake the test if you do not pass the first time.

After you take the post-test and pass, you will be asked to submit a training evaluation. You must submit the training evaluation to get your certificate of completion. The training evaluation is 11 questions. Please answer honestly about your experience with the training modules. If you have suggestions about what might be done to improve running this training as a group, please let me know.”



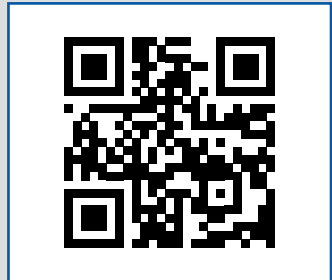

Sign up for a QSEP account before the first training session.

Note: You will need to use an individual email address that you can login to in order to set-up your QSEP account to get credit for the training.

- 1 Go to the Centers for Medicare & Medicaid Services (CMS) Quality, Safety & Education Portal (QSEP): <https://qsep.cms.gov> or scan the QR code.
- 2 Click on **Sign Up** and then **Providers & Other Learners**.
- 3 Fill out the **Tell Us Who You Are** form.
 - a. Enter your first name, last name, and email address.
 - b. Under **Select Your User Role**, select **Provider/Supplier** from the dropdown list.
 - c. Then click **Next** to continue registration.
- 4 Under **Provider/Supplier Type**, select **SNF/NF - Skilled Nursing Facilities/Nursing Facilities** from the dropdown list.
- 5 Select **Facility Search**.
 - a. Enter the facility name (first few characters), zip code or state. Click **Search**.
 - b. A list of facilities will appear. Select our facility from the list. Confirm your choice on the following screen and then select **Next** to complete registration.
- 6 You will be sent an email from CMS (donotreply@qsep.org) confirming your registration. Click on the link in the email. It may take up to 30 minutes to get this email.

User Guide: CMS Targeted COVID-19 Training for Frontline Nursing Home Staff and Management

The Centers for Medicare & Medicaid Services (CMS) developed these free, self-paced, scenario-based trainings for frontline nursing home staff and management, focusing on using best practices to protect residents and contain and prevent the spread of COVID-19. The trainings are hosted on the [CMS Quality, Safety & Education Portal \(QSEP\)](#) and are available on-demand, 24/7.

Each training includes a mandatory **pre-test** and **post-test**. To receive a certificate upon completion, you must score a minimum of 80 percent on the post-test. Continuing education units (CEUs) are not available.

The frontline nursing home staff training includes the following modules and takes about 3 hours to fully complete all the modules:

- Hand Hygiene and Personal Protective Equipment (PPE)
- Screening and Surveillance
- Cleaning the Nursing Home
- Cohorting
- Caring for Residents with Dementia in a Pandemic

The nursing home manager training includes the same modules listed to the left, as well as the additional modules listed below and takes about 4.5 hours to fully complete all the modules:

- Basic Infection Control
- Emergency Preparedness and Surge Capacity
- Emotional Health
- Telehealth for Nursing Homes
- Getting Your Vaccine Delivery System Ready

BEFORE YOU START, make sure you have:

- A working email address. You will need to access the inbox for the email address you use to register.
- Access to a computer, smartphone or tablet with internet access.
- Computer speakers or headphones to listen to the audio in the training (closed captions are also available if needed).
- A notebook or paper and a pen for taking notes.

Steps to access and complete the trainings:

- 2 Click on **Sign Up** and then **Providers & Other Learners**.
- 3 Fill out the **Tell Us Who You Are** form. Enter your first name, last name and email address. **Under Select Your User Role**, select **Provider/Supplier** from the dropdown list. Then click **Next** to continue registration.
- 4 Under **Provider/Supplier Type**, select **SNF/NF - Skilled Nursing Facilities/Nursing Facilities** from the dropdown list.
- 5 Select **Facility Search**. Enter your primary facility CCN (CMS Certification Number), facility name (first few characters), zip code or state. Click **Search**. A list of facilities matching your criteria will appear. Select your facility from the list. Verify your choice on the following screen and then select **Next** to complete registration.
- 6 You will be sent an email confirmation. Click on the **link** in the email. It may take up to 30 minutes to receive this email. If you do not receive the confirmation email within 30 minutes, please contact helpdesk@qsep.org.
- 7 After confirming your email, return to the QSEP homepage (<https://qsep.cms.gov>). Click on **Login**. Select **Providers & Other Learners**. Enter your email address to login to QSEP. You will be sent to the **QSEP Training Catalog**.
- 8 Use either the **search field** or the **alphabetical listing** to locate the training. The training names are:
 - **CMS Targeted COVID-19 Training for Frontline Nursing Home Staff**
 - **CMS Targeted COVID-19 Training for Nursing Home Management**
- 9 Select the **Launch** button at the right side of the window beside the course listing.
- 10 The **Training Menu** page will be displayed. Click to begin the **Pre-Test**.
 - Read each question carefully. Some questions may have more than one answer.
 - Click on **Submit Answer** to go to the next question. (*Note: Do not click the Back browser button. If you do, you will exit the test.*)
 - Pre-test progress is saved automatically. If you exit a pre-test, you may return within 14 days and continue where you left off. You will be required to restart the pre-test if you return after 14 days.
 - Pre-tests are not scored, but your responses may be stored for statistical purposes.
- 11 After completing the pre-test, click to return to the **Training Menu** page. Now you may start the training. Click the **play** button. Load times may vary based on your internet connection. Please allow up to one minute for the training to start.
- 12 A test-out option is available for each training module if you choose **Attempt to Skip**. If you achieve a score of 80 percent or higher on a short quiz before you start the module, you will receive full credit for the module. You may proceed to another module. The training modules may be completed in any order. (*Note: If you exit the training before you complete it, make sure you note which module you were on so you can jump ahead to the correct spot when you return to complete the training. The system will not automatically resume where you left off.*)
- 13 After completing the training, click to return to the **Training Menu** page. Choose the **Post-Test** option. You must get at least 16 of the 20 post-test questions correct to pass. You can retake the test if you do not pass the first time.
- 14 After completing the post-test, return to the **Training Menu** page. Select the **Training Evaluation** link. Answer the evaluation questions. Select the **Submit Evaluation** button at the bottom of the survey.
- 15 Once the evaluation is submitted, select **Click to View/Print Your Completion Certificate**. You can also log in to QSEP to download the certificate later.

How to Get Your Certificate for Completing CMS Targeted COVID-19 Training for Frontline Nursing Home Staff

You must complete a post-test and a training evaluation in order to get your training certificate.

TAKE THE POST-TEST

First, take a 20-question post-test. You must answer at least 16 questions correctly to pass. You can take the post-test as many times as you need to.

- 2 Click **Login**.
- 3 Click **Providers & Other Learners**.
- 4 Enter the email address that you used to register for an account. Click **Next**.
- 5 Scan the QR code or type **COVID** in the search box and tap **Go**.
- 6 Tap the + to find **CMS Targeted COVID-19 Training for Frontline Nursing Home Staff** (may be second + down).
- 7 Tap **Launch** if this is your first login or **Resume**.
- 8 Scroll to the bottom of the page to take the **Post-Test**.
